*How many electives am I required to take in the MAcc?*

- **Tax Stem** students are required to take a minimum of **9 credits** of approved electives in addition to **3 credits** of tax electives (see Tax Stem outline for tax elective course list).
- **Professional Stem** students are required to take a minimum of **3 credits** of Analytics and Technology elective courses and **15 credits** of approved electives (**total of 18 elective credits**). Analytics and Technology elective credits beyond the 3-credit minimum will count towards the 15 credits of approved electives.

*What is the purpose of an emphasis?*

The purpose of an emphasis is to aid in selecting electives that align best with your career goals. We have organized optional emphases to choose from (listed below), with faculty mentors you can consult about each emphasis and associated career opportunities. Each emphasis requires 9-12 credits. You may pursue **more than one emphasis**. Some emphases also suggest certifications beyond CPA licensure you may consider. **If you have questions about the significance of an emphasis**, please contact one of the faculty mentors associated with the emphasis.
