

- **Tax Stem** students are required to take a minimum of **3 credits** of a tax elective and **9 credits** of approved MAcc elective courses (**total of 12 elective credits**).
- **Professional Stem** students are required to take a minimum of **3 credits** of Analytics and Technology elective courses and **15 credits** of approved MAcc elective courses (**total of 18 elective credits**).
