

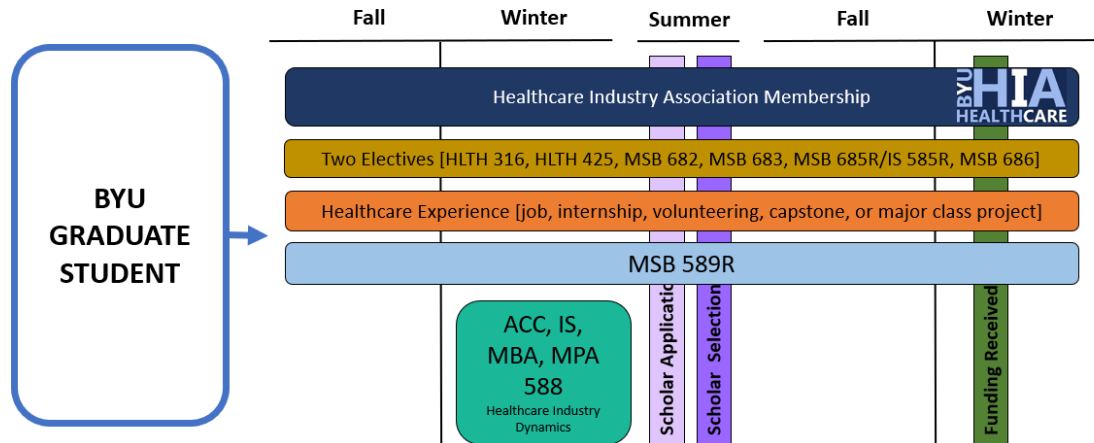
2021-2022 Healthcare Industry Scholar Graduate Student Application

Overview

BYU graduate students preparing for careers in the healthcare industry may apply to become a *BYU Healthcare Industry Scholar*. This advanced educational opportunity provides healthcare management exposure to complement students' developing disciplinary skills (accounting, data analytics, ethics, finance, human resources, information systems, marketing, operations management, organizational behavior, strategy, supply chain management, and other specializations). Students selected as Healthcare Industry Scholars will receive scholarship funding during the semester in which they complete the last class requirements for the scholarship.

Note: Those students who are graduating in December will apply the same year they are graduating (i.e., May 2021 application for December 2021 graduation).

Short Essays

Essay 1: Statement of Interest **(150-word limit)**, demonstrating academic, work, volunteer, leadership experience, or other life experiences relating specifically to healthcare.

Essay 2: Statement of Intent **(100-word limit)**, career plans relating to healthcare, including plans immediately after graduation as well as longer-term career goals.
